10-1 WARRANTY

PLEASE CONSULT YOUR PHYSICIAN BEFORE USING THIS PRODUCT.

This Warranty applies products manufactured or distributed by Joong Chenn Industry Co., Ltd under the FITNEX brand name. The warranty period to the original purchaser is 3 years on frame and 1 year on ALL parts.

FITNEX warrants that the Product you have purchased for non-commercial, personal, family, or household use from FITNEX or from an authorized FITNEX reseller is free from defects in materials or workmanship under normal use during the warranty period. Your sales receipt, showing the date of purchase of the Product, is your proof of the date of purchase. This warranty extends only to you, the original purchaser.
